# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.thesounddoula.com, and The Sound Doula and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to The Sound Doula include www.thesounddoula.com. The The Sound Doula website is a service and information site. By using the The Sound Doula website, you consent to the data practices described in this statement.

# **Collection of your Personal Information**

In order to better provide you with products and services offered, The Sound Doula may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address

If you purchase The Sound Doula's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. #### **Use of your Personal Information**

# **Sharing Information with Third Parties**

The Sound Doula does not sell, rent or lease its customer lists to third parties.

All such third parties are prohibited from using your personal information except to provide these services to The Sound Doula, and they are required to maintain the confidentiality of your information.
